

Paslode New Zealand Online Giveaway - Terms and Conditions

Participation in this Promotion is deemed acceptance of the following terms and conditions:

How to Enter:

1. Simply register a Paslode tool to go into the draw to win a Paslode Summer Prize Pack.
2. Visit <https://www.paslode.com.au/register-account> and complete the online registration process.
3. There are no restrictions as to the number of entries you may make in this promotion. However, you can only enter once for every tool you register.
4. The promotion commences on 5 December 2022 and closes at midnight on 18 December 2022 ("Promotion Period"). Qualifying registrations must be made between these dates.
5. Entries are deemed to be received at the time of receipt by the Promoter. Records of the Promoter are final and conclusive as to time of receipt.

Prize & Prize Draw:

6. There is one prize pack nationally. The Paslode Summer Prize Pack ("the Prize") includes:
 - (a) 1x Weber Traveler BBQ
 - (b) 1x 40L Icey-Tek Chilly Bin
 - (c) 1x Stoney Creek Towel Hoodie
 - (d) Paslode summer merchandise.
7. The "Winner" is defined as the person whose name is drawn in the Prize Draw held on 19 December 2022. If a Winner cannot be contacted 14 days after the above date, a new winner will be drawn on the 15th day. This process will repeat until a Winner is contacted.
8. The draw will be undertaken by a representative of the Promoter.
9. The Promoter is not responsible for any notification that is misdirected, lost or damaged, or if the Winner cannot be contacted due to incorrect details being provided in the entry/registration form.
10. The Prize, or any portion/part of the Prize, is not transferable or exchangeable and cannot be taken as cash.

11. If any Prize remains unclaimed after 19 March 2023, the Prize will be forfeited.

General Terms and Conditions of Entry:

- (a) are residents of New Zealand aged 18 years or older; and

13. The Promoter reserves the right, at any time, to verify the validity of claims and Eligible Entrants (including an entrant's identity, age and place of residence) and to disqualify any claimant who submits an entry that is not in accordance with these terms and conditions.

15. The Promoter’s decision is final, and no correspondence will be entered into.
16. Incomplete, indecipherable, or illegible claims will be deemed invalid.

 - (d) any tax liability incurred by a claimant or Entrant; or
 - (e) use of the Prize.
